Megan Thiele read minutes from the previous meeting.

Business arising from the minutes:

- Clarification on what was donated by Cenovus and making sure the donation was acknowledged publicly (outside of social media).
- School website needs updating, information is not easy to find or is not up to date.

School Update:

- Lori Bartee presented our school goals (document attached)
- Three grants have been received
 1. Mosiac grant, valued at \$15,000, will be used to purchase a dishwasher and commercial fridge for the home ec room.
 - New cupboards will be purchased and installed by the division (date unknown)
 2. Division grant, valued at \$39,000, to be put towards the multi purpose room (formerly the senior art room) and an outdoor classroom. Kate Renwick and Kaila Utz taking the lead on planning the outdoor classroom project. Possible location is near the large outdoor shed.
 3. Division grant, valued at \$3,600, to be put towards snacks and lunches for students who may not have food at school. Chantelle Kayln (Wellness Coordinator) will be involved in organizing this.
- Cenovus Food Forest project has been completed. Grade 10-12 students helped with the planting.

- Extra Curricular Report:
 - o Cross country running was coached by Mrs. Gagnon, Mrs. Nasby and Ms. Preddy. 18 students participated from grades 3-8.
 - o 4 volleyball teams running (Junior boys and girls & Senior boys and girls). Junior season will end late October and Senior will run into November.
 - o Mr. Filion is leading a choir program and a jazz band program.
- Staffing:

 - o Tennielle Stewart - Grade 11 Homeroom
- Enrollment is down slightly from last year at 196.

- New custodians were hired through a contract company – Oliver & Mary Grace Noceda. Contract runs until the end of August 2026.
